- The United Nations Office for Project Services (UNOPS) now invites bids from eligible bidders for the Provision of Hotel Services for Accommodation and Conference facilities in Denmark/Sweden under the terms set forth in the ITB.

- 3. The deadline for bid submission is 25 November 2019 at 13:00 UTC (14:00 hrs in Copenhagen time).
- 4. UNOPS will hold a Clarifications meeting on 13 November 2019 at 11:00hrs in UN City Copenhagen, Marmorvej 51, DK-2100. Interested Bidders must communicate the names of their representatives who are nominated to attend the clarification meeting and latest one day before the meeting through the eSourcing or through email BuddhikaK@unops.org in order to obtain an entry permit to UN City.
- Please note that interested bidders must submit bids in response to this tender using the UNOPS eSourcing system, via the UNGM portal. Bids submitted through sealed envelopes or emails will not be accepted.
- 6. In order to access the full UNOPS tender details, request clarifications on the tender, and submit a bid to a tender using the system, vendors must be registered as a UNOPS vendor at the UNGM portal and be logged into United Nations Global Marketplace (UNGM).

The United Nations Global marketplace is a database of active and potential suppliers available to all UN and World Bank procurement personnel, and is the main supplier database of more than 20 UN organizations.
